



ADDITIONAL CONDITIONS THAT MUST BE MET

1. PARKING AVAILABILITY
2. INSURANCE CERTIFICATE-LIABILITY \$1,000,000
3. CERTIFICATE OF FIRE RESISTANCE ON TENT
4. AN ELECTRICAL PERMIT MUST BE OBTAINED BY A LICENSED ELECTRICIAN AND A BUILDING PERMIT MUST BE OBTAINED
5. TWO PORTA POTS MUST BE AVAILABLE
6. INSPECTION BY OUR CONSTRUCTION CODE OFFICIAL
7. IN SETTING UP SEATING, AISLES MUST BE CREATED AND TWO EXITS MUST BE ESTABLISHED EVEN THOUGH THE ENTIRE TENT IS OPEN THE EMERGENCY LIGHTING AND EXIT SIGNS MUST BE INSTALLED.
8. ALL TRASH AND DEBRIS IS TO BE REMOVED AND THE PROPERTY LEFT IN RESPECTABLE CONDITION
9. ANY PROBLEMS ARISE THE CITY HAS THE RIGHT TO RESCIND THIS PERMIT.
